7. Eligibility Born on or after January 1st, 2002.
All the association affiliated to LATTU
Only associations which are not in arrears (including the 2017 affiliation quotas) with both LATTU (\$150 usd) and ITTF (\$150 usd) may nominate players to participate.
This requirement is an obligation.
Those countries that wish to pay dues of other years during the tournament, can do it.

8. Format of play

- 8.1 Teams:** The World Championships System will be used Each National Association can enter one team per gender with the exception of the Host Association that can enter 2 teams per gender.
A team shall consist of 3 players for each match. The order of play shall be A-X, B-Y, C-Z, A-Y, B-X. All matches will be played best of 5 games.
The competition will be played in two stages:
- First Stage: Preliminary groups of 3-4 teams (round robin).
- Second Stage: Knock-out
- 10.2 Doubles:** Each National Association can enter up to 2 pairs per event.
Matches will be best of 5 games. Pairs must be composed by from the same Association.
The host association can enter double number of pairs.
- 10.3 Individuals:** The competition will be played in two stages:
- First Stage: Groups of 3-4 players. Matches best of 5 games
- Second Stage: Knock-out. Matches best of 5 games
The host association can enter maximum 4 players.

A participant's refusal of above listed coverage may be subject to suspension or dismissal from the competition.
